

## **2021-2022 Natural Venom All Star Prep/Novice Program**

What is a Half Year team? Our Half Year program is an opportunity for your child to get the All Star experience. They will be exposed to a different side of cheerleading, with more challenging skills, a high level of teamwork and the glitz and glam of all-star cheerleading on competition day. The prep program is for ages 6 & up!

Placements will be October 2nd, 2021 at 11:00am with their first official practice the week of October 11th. Teams will attend 2 All Star competitions either virtual or in person depending on Covid Phases.

**\*\*Practice days will be determined by how many teams we are able to form.**

**\*\*Please note that as we near competition season additional practices may be added on an occasional weekend to make sure teams are ready. We will give as much notice as possible for any extra practices.**

As this is a prep/novice team, the cost of joining is significantly less than a full year team and you will still get the opportunity to compete at All Star competitions.

**Costs:** Monthly Tuition= \$195/month November-April Due at the 1st of each Month.

- Tuition includes- monthly gym fees, competition fees, music fees, choreography fees, T-shirt, Bow and Uniform!

\*Registration - \$50 due at first practice

### **Competition Schedule- COMPETITIONS ARE 100% MANDATORY**

- Full dates and competitions we are attending will be sent out December 1st, 2021.
- We will be attending 2 All Star competitions either in person or virtual depending on Covid phases.

### **Financial Commitment**

If your athlete quits or is removed from Natural Venom for any reason, all monies paid non-refundable including but not limited to try-out fee, tuition, clothing fees, etc.

### **Competition Entry Fees/National Fees**

If an athlete is injured or has to be removed from the routine for any reason, all competition fees paid on their behalf are non-refundable. Competition fees pay for a position on the mat, and if your athlete is unable to fill that position, the competition entry fees, having already been paid, will be reallocated to the athlete that steps into that position.

### **Apparel/Uniform Fees**

If an athlete quits or is dismissed for any reason, Natural Venom will not issue refunds for apparel or uniforms nor will items be released to the athlete. After a child has left the program, all items purchased are forfeited and become property of Natural Venom.

### **Other activities & extra curricular sports**

If your child chooses to participate in other activities/sports, we require that Natural Venom All Stars are their first priority. When there is a conflict, it needs to be communicated immediately to the coach(es), in order to come up with a solution.

### **Withholding Cheer as a punishment**

Natural Venom All Star families must agree not to withhold participation as a punishment tool, as they would use, "taking away television or internet", or "not going out with friends". This is because every member of a team depends on every other member's participation. Natural Venom All Stars is committed to working with parents in order to handle scholastic and behavior problems. A parent withholding participation, not only punishes their child, they also punish all the other children on their team. We do respect that a parent has the right to discipline their own child, but they do not have the right to punish the other children and families who have worked hard and invested their time and money in our program.

### **Attendance Policy**

100% attendance! At Natural Venom we believe that teams becoming great by working together. Because cheerleading is a team activity every team member must be present in order for the team to be successful. If your child misses numerous practices they may be removed from their spot on the team.

### **Injury Policy & Attendance**

If your child has an injury or becomes injured, they must submit a doctor's note detailing the nature of their injury, restrictions and the time of recovery recommended. If an athlete is injured, they must still attend practice, although they may sit out of some or all activities in accordance with doctors' orders.

### **Sportsmanship**

Good sportsmanship is the ability to look past one's own team and to honestly admire the skill and talent demonstrated by other teams and squad members and to sincerely hope that all competitors perform well. Natural Venom fans, parents, friends, spectators, and competitors are known for our appropriate behavior and good sportsmanship. As representatives of Natural Venom, we ask that you always exhibit good sportsmanship, say only positive comments, and act with integrity when interacting with other teams and competitors.

### **Risk of Cheerleading**

Parents and athletes should be aware that all-star cheerleading is a highly competitive and dangerous sport that carries with it an inherent risk of danger. Stunting, tumbling and all other aspects of cheerleading and training can lead to injury. At Natural Venom we take every precaution to limit injuries; however, as with any competitive sport, the possibility for injuries to

In an emergency situation we will do whatever we feel is necessary for the wellbeing of your child. If we feel your child needs immediate emergency medical attention we will call 9-1-1. By signing this contract you agree to this and give the coaches permission to do what they deem necessary in the event of an injury. All athletes must also have a signed Liability Release that is always present. Athletes must have a waiver on file before they will be allowed to practice.

**Natural Venom All Stars Handbook Agreement for 2021-2022 Competitive Cheerleading  
Season**

I have read, agree to, and understand all terms of the 2021-2022 Natural Venom All Stars Handbook. I understand that if I, any member of my family, or my child breaks or violates any of the policies listed in this handbook that Natural Venom All Stars has the right to enforce consequences.

If my child quits the team or is dismissed from the program for any reason, I understand that any fees paid are non-refundable; all uniform and apparel not distributed will forfeit and become the property of Natural Venom All Stars. I will be held liable for paying any fees that are past due and will be held responsible to pay the \$150 withdrawal fee that is effective December 15th, 2021. Furthermore, I understand and agree that I will be responsible to pay all costs and attorney fees incurred by Natural Venom All Stars in connection with any dispute, collection action or litigation arising out of this agreement.

Accidents can be a result of the nature of the activity and can occur with or without fault on either part of the athlete, the gym, Natural Venom, its employees, agents or the facility where the activity is taking place. By allowing your daughter/son to participate, you are accepting the risk of an accident occurring and agree that the activities carried out in the course of an activity facility and cheerleading club are suitable for your child. By participating, you are admitting awareness of the usual risks and dangers inherent in participation in all of the activities offered at the cheerleading gym and associated with Natural Venom All Star Cheerleading and the possibility of injury both minor and serious, property damage or loss of death resulting from the activities. I waive any and all claims I may have against and release all liability and agree not to sue South Sound Spirit Group, Natural Venom All Star Cheerleading, Natural Venom coaching staff, agents, or volunteers for any personal injury, property damage or loss sustained as a result of my child's participation in the program, arising out of any cause whatsoever.

Media Release- I understand that Natural Venom All Stars athletes may be filmed and photographed for promotional and documentary reasons. I give permission for my child to be both filmed and photographed, and for those images to be published by Natural Venom or any other affiliated company. I understand that neither I nor my child will receive royalties for any published videos or photographs.
